We have a huge phosphorous problem - will be partnering to do a water quality assessment so as to pursue future funding for clean water.

Weed cutting - Dwight Evers - Able to cut the entire main lake, once around. Much appreciation for all the volunteers. Lake was too low to ever get the second cutter back in the lake.
